February 2, 2020

Congregational meeting with 30 voting members in attendance.

Eric introduced Bishop Sid Haugen and explained his role to witness the voting of a call for pastor and to sign the Letter of Call and the Employment Agreement.

Eric explained that the first part of this meeting will be to discuss a call to Melissa Brooks for a part time pastor.

Eric described the call process and the agreement.

Bishop Sid H then described further details.

Discussion held.

***MSC** to accept a show of hands for voting today (no secret ballots required)

***MSC** to call Pastor Melissa Brooks as FSLC's Rostered Leader (unanimous)

***MSC** to approve the presented "Letter of Call" and "Employment Agreement" for a 25% of a Full Time leader providing the same services we have now. (unanimous)

Bishop explained that to obtain services not covered by the Employment agreement (out of scope) use the Synod website or call the Synod office or ask Melissa to assist.

Above process was witnessed and approved by the Bishop, Sid Haugen

The above portion of the meeting was completed by 10:16 and a break occurred prior to proceeding with the agenda items for the annual meeting.

Eric Anderson chaired the annual meeting and followed the agenda as presented in the annual report.

**Radisson - Langham Lutheran Parish
Chairperson's Report 2020**

There is little doubt that 2020 will long be remembered as the year we would rather forget. The year started off filled with great expectations and lots of hope: our Parish put forth a Call to Rev. Melissa Brooks to officially become our part time Rostered Pastor. This Call process would formalize the service agreement we had arranged together with Pastor Melissa in previous years. Each congregation had to vote on this in early February, and an installation ceremony was being planned for April.

Just before that could happen, along came the Covid-19 pandemic, and in-person worship at our churches was shut down in response to a March 16 letter from the ELCIC National and the Synod Bishops encouraging congregations to "suspend public worship services and other gatherings effective immediately" to help against the spread of COVID-19.

Throughout the difficult months from March through December, I have been fortunate to be able to share most of the burdens of decision-making for the Parish with Eric Anderson, First Saskatchewan Council Chair and therefore serving as our Parish Vice-Chair! Eric's management skills and attention to detail were matched by his never-ending good nature. Thank you, Eric... so much we had to do together "on the fly" and you always made things easy! A special thanks, too, to Doris Hamp who has always made sure our congregations received regular weekly bulletins, supporting us with information and love.

Although Pastor Melissa ultimately decided to tender her resignation as our Rostered Pastor effective November 15th, between April and September she happily jumped into "televangelist" mode, providing videotaped Sunday morning services posted on YouTube, with prayers, some music, readings and a sermon. This was welcome, and we enjoyed hearing from her (patiently assisted by Matt and the girls) through the summer and into early fall, when we were able to resume very limited in-person services (30/20 person attendance), and of course following strict health department protocols.

Knowing we would be again without a Pastor, and to plan for Advent, we approached three supply pastors who could serve us into early January, but as things turned out, that was not to be. The pandemic surged again; St. Paul closed to in-person worship beginning on November 8th and continuing at least through January. First Saskatchewan followed suit two weeks later, closing to in-person worship beginning November 29th.

We continue to "make do", reaching out to our congregations through the weekly bulletins and endeavouring to bring reflections and provide online options through this year. We will need to continually assess the realities of this pandemic alongside the desires and needs of our congregations. So far I am hearing that we should continue as we have been doing, at least until we can - with some confidence - re-open, then carry on with supply pastors two or three times each month.

FSLC 2020 events -

I guess God did not want us to be like the "O Little Town of Bethlehem" this year and sleep-through the arrival of Jesus, nor be too busy with our business and lives to accept the arrival of Jesus into our homes that night too. There were a lot of small campfire Christmas suppers, but we were also blessed with snow to play in and warm weather to enjoy it. It looked as if the whole thing was planned, didn't it?

2020 started out exciting as we were hiring Pastor Melissa Brooks as the Rostered Pastor for FSLC and St. Paul in a part-time position. And then, due to COVID 19 restrictions put on by the Provincial government and the Saskatchewan Health Authority life changed, both within the church and within all other aspects of life.

In mid-March we changed from in-person Church services to on-line services due to the pandemic Corona Virus (COVID 19). We forged ahead with links to the recorded services and the bulletins were electronically sent to all members and others as available. Although remote for the first 3 Sundays of the month, we forged ahead in this format from March thru to September.

There were 3 weddings held at FSLC during the summer and two funerals, both were small in attendance as COVID 19 regulations were followed.

On September 27, church services resumed in the church, but with substantial changes due to adhering to COVID 19 safety requirements.

Pastor Melissa Brooks resigned her position as of November 15, 2020 and although it was a difficult year, we thank her for adapting to remote services and thank her for everything she did for FSLC over the past years she served us.

Upon her resignation and then due to another round of health advisories, plus advice from Synod to not hold in-person services until at least the end of January 2021, FSLC began to rely upon online services from other churches.

Given the tumultuous year, FSLC council members remained in their positions as there was no congregational election meeting, and we hope 2021 brings an end to COVID 19 and enables us to worship God together in person as soon as it is safe to do so.

We begin 2021 with the dissemination of COVID-19 vaccines and a shocking appreciation of being able to gather together for worship. We have also had a Christmas to focus on its true meaning - a Christmas without distractions. Perhaps we will adopt some of these learnings into our lives going forward.

We continue to pray for everyone's safety.

Radisson - Langham Parish Agreement

BETWEEN: St. Paul Lutheran Church, Radisson, Saskatchewan

AND: First Saskatchewan Lutheran Church, Langham, Saskatchewan

PREAMBLE:

In the Name of the Father, Son and Holy Spirit. Amen.

Prompted by a common need and mutual concern for an effective witness in their communities to the saving love of God in Christ Jesus our Lord, and out of heartfelt desire that those who are now members of churches may continue to have opportunities for growth in grace and sanctification afforded by participation in congregational life, the congregations of St. Paul, Radisson, and First Saskatchewan, Langham, hereby voluntarily renew their two-point parish agreement.

TERMS OF AGREEMENT:

1. It is understood that the pastor will maintain and develop the programs as needed in each congregation. The programs are understood to embrace those matters which are stipulated in the Constitutions of the respective congregations and such additional matters as arise out of the heritage or traditions of the respective congregations.
2. The parish council shall consist of twelve members: six from each congregational council, including their chairperson, secretary, treasurer, and three other council members. A quorum consists of at least seven parish council members, three from Radisson and three from Langham, plus one from either congregation.

They shall:

- i) Meet at least twice annually. Meetings shall be announced at the regular Sunday service of each congregation prior to the parish meeting.
- ii) At the first parish council meeting following the congregational annual election meetings, elect a parish executive consisting of a chairperson, vice-chairperson, secretary and treasurer.
- iii) Require a two-thirds majority vote of parish council members on a motion requiring referral to the respective congregations.

3. A parish council is to be elected whose purpose is to:
 - i) Discuss plans, and initiate programs for the entire parish.
 - ii) Resolve any problems which may arise in the functioning of the parish.
 - iii) Prepare a parish budget and make recommendations to the congregations for approval in financial matters such as:
 - a) Pastor's salary, pension, car allowance and benefits.
 - b) Pastor's housing.
Where pastor's housing is the manse provided by St. Paul, Radisson, the parish pays for the regular maintenance of the manse property, but does not pay for new additions to the property.
 - c) Costs associated with operating the parish office.
 - d) Other costs incurred in the operation of the parish.

- iv) Allocate the annual parish budget to the congregations according to the proportion of voting members (18 years and over) in each congregation as of the date of the parish budget meeting who communed at least three times during the previous year.
- v) Maintain a parish treasury, from which the parish treasurer shall receive and disburse budgeted funds.
- vi) Arrange for the review of parish financial records.

4. This parish agreement will be in force for a three-year period, subject to revision and renewal at the end of that time. The agreement may be terminated by a majority vote of either congregation, provided one year's written notice is given of the intention to do so.

5. The time of worship is to be as follows: Langham - 9:00 a.m., Radisson - 11:00 a.m. This schedule is to be reviewed, continued or revised by the action of the parish council.

This agreement is to be signed by the chairperson of each congregation, and by the Bishop of the Saskatchewan Synod, Evangelical Lutheran Church in Canada. Copies of this agreement are to be filed with the pastor, with the chairperson and secretaries of each congregation, and with the Bishop of the Saskatchewan Synod, Evangelical Lutheran Church in Canada.

Having been authorized to do so by action taken at congregational meetings, we the Chairpersons of the congregations affix our signatures to this renewal agreement of the Radisson-Langham Lutheran Parish.
